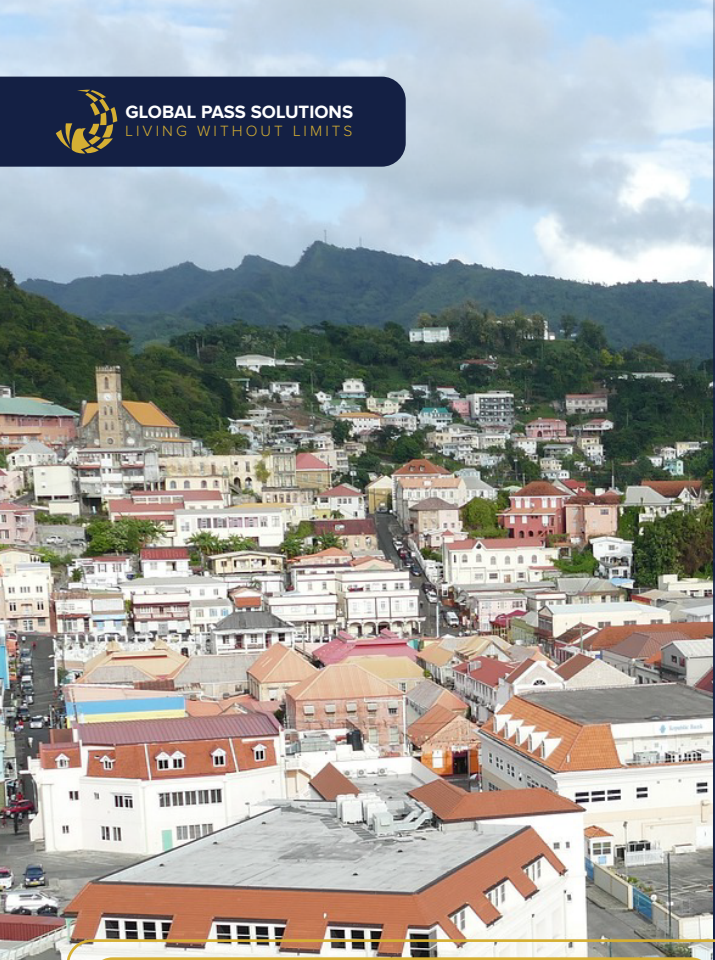

1. Fast Track Residency

- Become a full citizen in just 5-8 months.

2. Visa Free Travel

- Visa-free or visa-on-arrival travel to over 143 destinations, including the Schengen area, China, UK, Russia, Singapore, Hongkong.

3. Family Eligibility

- The ability to include a spouse, children under 30, unmarried siblings aged 18 and over, parents, and grandparents of the main applicant and spouse of any age.

4. Dual Citizenship

- No restrictions on dual citizenship in Grenada.

5. Attractive Tax Regime

- No taxes on wealth, inheritance, income, or gifts.

6. No Residence or Visitation Requirements

- No minimum stay required.

7. Commonwealth Citizenship

- Grenada's citizens are entitled to special privileges across the British Commonwealth, including the UK.

8. Gateway to US E-2 Treaty Visa

- Eligibility to apply to the USA for a nonimmigrant investor visa after being domiciled in Grenada for a continuous period of at least three years, due to the country's E-2 Investor Visa treaty.

9. Access to American Medical Education

- Grenada is home to the US's largest offshore medical university St. George's University of the United States of America in Grenada.
